## Fees

### Initial Consultation

When something is going “wrong” in your life, this consultation uncovers whether we have what you need to recover. It’s free and usually takes fifteen to twenty minutes. If after 20 minutes, you wish for more time on this call, that can be arranged. After the 20 minutes free time, the fee is \$38.00 for each 1 to 10 minute increment.

### Additional Services

Scheduling additional time for services is dependent upon what is found during your Initial Consultation.

Future Consultations are scheduled 30 to 60 minutes each.

### Food as Medicine

When various foods from the grocery store will heal your “wrong”, you will be asked for details:

- Three consecutive days period of food and drink consumed;
- The amount of water consumed each day in ounces;
- A complete list of your symptoms;
- A list of medications and food supplements with the name of the manufacture and a note as to why you are taking it.

The Food as Medicine fee includes the Report of Findings of 1 to 1-1/2 hours.

Fee: \$670

### Quimby's Method Sessions

Quimby's Method requires a commitment of three to eight session hours. These sessions are unique in their scheduling. Each time you are scheduled, it will be for one full hour. However, due to the intensity of the work, your session may at times only last for 20 to 40 minutes. Clients are not charged for unused time.

8 Session hours \$1,824

### Payment Options
